

Cookies statement

Personal data protection is very important to us. In the following document we will inform you about the use and settings of cookies.

Who is the personal data manager?

When do we process your personal data?

We process your personal data in case you sending a contact form, subscribing to a newsletter and sending a CV with the goal to arrange an interview and signing an employment contract, adding a comment under Regulation (EU) No 2016/679 of the European Parliament and of the Council in the context of the processing of personal data and the free movement of this data and about repealing Directive 95/46 / ES (the General Data Protection Regulation).

When you sending a contact form, we process the following personal data:

- **E-mail address**
- **Name and surname**
- **Phone number**
- **Text of the message**

This personal data must be processed to process your CV and be included in the schedule of the personal interview. For such processing is Article 6, paragraph 1, letter b) Regulation. This personal data will be processed by personal data manager for the duration of negotiations on the conclusion of an employment contract, at the latest 5 years after your request (your interest), unless you give your consent for further processing.

When subscribing to newsletters, we process the following personal information:

- **Email address**

We process this personal information for the purpose of sending commercial messages. We process the email for 3 years. We send you business communications with your consent. You can simply unsubscribe from sending commercial messages at any time. For such processing is Article 6 paragraph 1) letter a) Regulation.

When you post a comment, we process the following personal information:

- **Name**
- **E-mail address**
- **Comment**

We process this personal information to respond to your comment. For such processing is Article 6 paragraph 1, letter f) Regulation.

Who else can have an access to your personal information?

Personal data manager works with other subjects (Personal data administrator) who may have access to your personal information.

Statement on the use of cookies

What are cookies

Cookies are short text files created by a web server and stored on your computer via a browser. Later, when you return to the same site, the browser sends the stored cookie back and the server retrieves all the information it previously stored with you. The vast majority of websites use cookies for their activities.

How cookies are divided

Cookies can be divided according to who places them on the web:

1. First party cookie - their validity is limited to the domain of the site you are viewing. These cookies are considered safer.
2. Third party cookie - placed by a script from another domain. Users can be tracked across domains. They are often used to evaluate the effectiveness of ad channels.

According to durability, cookies can be divided into:

1. Session cookies - they are deleted from your computer when you close the browser
2. Persistent cookies - they are preserved after closing the browser, they are only deleted after a very long time (depending on your browser settings and cookie settings). You can also manually delete them.

According to the purpose we can divide the use of cookies as follows:

1. Technical - enable basic web site features (such as sign-in) or pages (such as playing videos, sharing content, etc.)
2. Analytical - used to collect non-anonymous data on user behavior. Based on these, we can customize the site to make it more comfortable for you.
3. Remarketing - Target ads to users. who have already been to our site.
4. Conversion - we can evaluate the success of your campaigns.

According to the purpose we can divide the use of cookies as follows:

1. Technical - enable basic web site features (such as sign-in) or pages (such as playing videos, sharing content, etc.)

2. Analytical - used to collect non-anonymous data on user behavior. Based on these, we can customize the site to make it more comfortable for you.
3. Remarketing - Target ads to users who have already been to our site.
4. Conversion - we can evaluate the success of your campaigns.

What we use for cookies

We use the following cookies on our website:

- Technical – first-party, short-term. They provide basic technical functionality of the website, ie login, use of services, etc.
- Google Analytics - first-party, long-term. They are used to generate anonymous web usage statistics.
- Google Ads – first-party, Long term, Remarketing, and Conversion.
- Skill - third-party, long-term, remarketing, and conversion.
- Facebook Pixel - first-party, long-term, remarketing and conversion.

Our website may use retargeting technology from Sklik operated by Seznam.cz, a.s. This allows us to show visitors who have already shown interest in our products our ads on the advertising network of Seznam.cz, a.s.

We never place sensitive or personal data in cookies. We may place User ID in cookies, but this doesn't allow third parties to identify a particular person.

How to adjust the use of cookies

Deletion

You can delete cookies in your browser - it is usually placed "History" of visited pages.

Blocking
